Electronic Case Reporting Use Case

- The Carequality Steering Committee adopted the Electronic Case Reporting Use Case Implementation Guide for production use in early June
- We have accepted applications for the first two Implementers of this Use Case, and are expecting the first live transactions in the very near future
- The activity to date centers primarily on the use of Direct messaging to provide electronic initial case reports to public health authorities via the APHL AIMS platform
 - APHL participates in Carequality as a partner of the eHealth Exchange, an existing CCA signatory

Queries by Public Health Agencies

- In May, the Carequality Steering Committee adopted a Carequality Policy on queries by public health agencies: <u>https://carequality.org/wp-content/uploads/2020/05/Carequality-Policy-on-Public-Health-Queries-During-COVID-19-Emergency-Adopted-5-7-2020.pdf</u>
- This policy recognizes and attempts to address two barriers to rapid Carequality adoption by PHAs:
 - Many/most Carequality Implementers are not able to support queries for the "Public Health" permitted purpose, without development that will take time to complete and deploy
 - There is a lack of clarity on what constitutes the "minimum necessary" data set for public health re: COVID-19, especially relative to the broad set of information released in a "Treatment" context
- The Policy lays out a number of conditions that, if met, can allow a PHA to query for public health using the Treatment purposeOfUse code
- It is OPTIONAL to honor these queries, and CCs representing PHAs taking advantage of this policy will be identified to all Implementers prior to their inclusion in the Directory
- We have received confirmation from most live Implementers, however, that they will support these queries
- There are two state public health departments actively pursuing connectivity under the Policy

FHIR Update

- We completed the first "official" iteration of the FHIR Implementation Guide last month

- It is currently out for review with the Implementer community and we are actively incorporating feedback
- You are also welcome to take a look and offer your own insights/comments
- We will be reconvening the Policy WG later this Fall to complete some sections around fees and non-discrimination



FHIR Update

- Feedback highlights
 - We made a clarification to language around Patient Matching in Section 1.3.2 - we agree that the language wasn't very clear and consider this to be non-controversial update to the IG
 - We made a clarification to language around how the Implementers should propagate corrections in Section 1.3.3 - we agree that the language wasn't very clear and consider this to be non-controversial update to the IG
 - We made a substantive update to language around how the Directory would denote FHIR based exchange. We originally stated that a new field was needed for the Directory, but in actuality, a new value-set was needed for an existing entry. See page 25 under section 5.1

 - Notification Type/Trigger definitions with a focus on setting

 - Current work focuses on the Gaps in Care notification
 - Dynamic registration
 - The Technical Workgroup continues its collaborative work
 - Incorporating FHIR IG elements
 - Drafting Full FHIR IG for Push
