#### **Update | Steering Committee Application Process**

- The Nominating Committee has identified a slate of proposed nominees for the Steering Committee's consideration
- Discussion and voting on the slate will occur at the Steering Committee's September meeting
- The Nominating Committee is also considering recommendations for increasing opportunities for new members to join the Committee without losing institutional experience from the many long-serving current members

# **COVID-19 Response**

#### **Electronic Case Reporting**

- We have accepted applications for the first two Implementers of this Use
  Case, and the first users are up and running in production
- Activity to date centers primarily on the use of Direct messaging to provide electronic initial case reports to public health authorities via the APHL AIMS platform
  - APHL participates in Carequality as a partner of the eHealth Exchange, an existing CCA signatory

### **Queries by Public Health Agencies**

 Reminder: in May, the Steering Committee adopted a Carequality Policy on queries by public health agencies:

- The Policy lays out a number of conditions that, if met, can allow a PHA to query for public health using the Treatment PurposeOfUse code
- It is OPTIONAL to honor these queries and CCs representing PHAs taking advantage of this policy will be identified to all Implementers prior to their inclusion in the Directory
- We have received confirmation from the overwhelming majority of live Implementers, however, that they will support these queries
- There are two state public health departments actively pursuing connectivity under the Policy
- The State of Washington has met all of the requirements to initiate queries in production under the Policy and is planning on an initial scope of querying a limited set of long-term care facilities

#### FHIR Update

 Completed the first "official" iteration of the FHIR Implementation Guide in June

- Currently being reviewed by the Implementer community and feedback is actively being incorporated
- Technical section is complete
- Finishing touches on Policy sections around non-discrimination and fees are needed
- Current Goals:
  - Carequality Advisory Council recommend adoption by the Carequality Steering Committee at the next meeting
  - Carequality Steering Committee formally adopt V1 of the IG for production use at the October meeting (10/1)

#### Image Exchange Updates

- Two of our early adopters, AmbraHealth and Philips, have begun partner testing and validation of the Image Exchange IG Supplement
- Their first Connectathon session was held on 8/4 and a second on 8/11
- As is typical, these first sessions largely resulted in the identification of further necessary follow-up needed to make the process work
- The organizations are working internally and will reconvene in a few weeks
- This activity marks an important step; however, in the process of validating the IG supplement and making concrete progress toward eventual go-live
