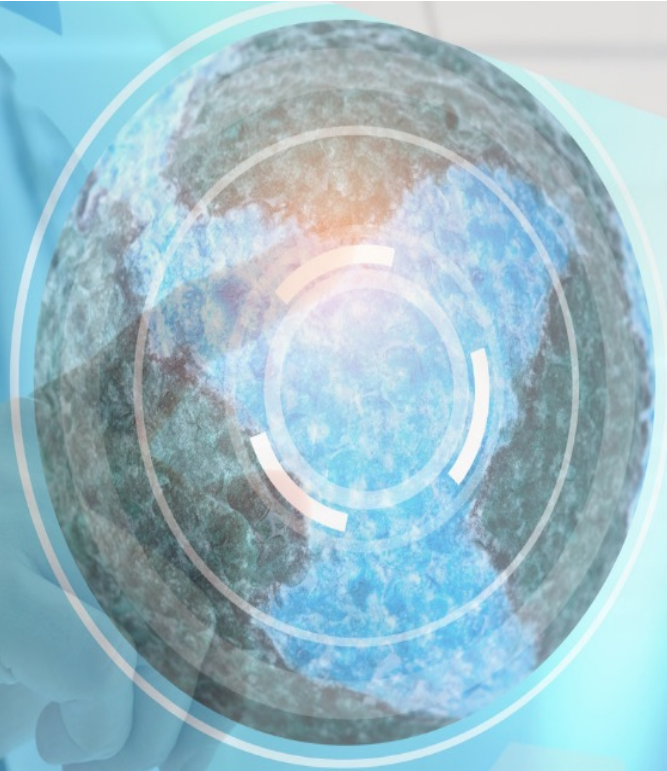

- 22 Certificates issued this month from the new Certificate Authority (CA)
- Continuing to work through some minor Implementer truststore issues and hope to have them resolved by April 30<sup>th</sup>
- We expect to really ramp up new CA certificate issuance in May
- Our goal of totally sunseting Entrust (our current CA) by Nov 1<sup>st</sup> remains unchanged

## Non-Treatment Exchange

- Since go-live, the Carequality ecosystem has been expanding. There are now a variety of organizations with use cases that were never envisioned.
