FHIR Workgroup

- As the Carequality FHIR Use Case matures, we are reviewing our certificate policies while attempting to get a better understanding of our Implementer's needs and requirements as it relates to certificates
- The community has expressed some concerns that the number of certificates needed to support a FHIR ecosystem will dwarf what we grew accustomed to in QBDE

FHIR R4 Directory

- We are in the final stages of our Directory/IG review process with Lantana
- We plan on wrapping up this review cycle and officially publish the new Directory IG sometime in April
- At that time, we'll allow Implementers access to a Development version of the new FHIR server and ask that they simulate real Directory interactions as a next step
- Assuming that goes well, we can then offer Implementers access to the new R4 Directory server in Production
