

#### FHIR Based Exchange - IG Update

- The workgroup has wrapped up its work and V2 of the IG is 99% complete. However – we are still addressing concerns raised around the proposed solution for managing the large number of certificates needed to support a FHIR ecosystem
- We continue to meet with internal and external stakeholders about this issue with an eye on crafting a design that also works for the QHIN Technical Framework (QTF)
- We plan on having a final resolution for the certificates/CA issue within the next few weeks

#### FHIR R4 Directory - Update

- We are closing the feedback loop for the Draft FHIR R4 Directory IG on 11/04/2022
- The FHIR R4 Dev environment has been open to Implementers for approximately 4 months
- We've made a couple of minor updates to the Draft Directory IG during this time
- We plan on releasing next steps & timelines for migrating to the R4 Directory during the Nov 8<sup>th</sup> Technical Forum call

#### Image Exchange Update

- We continue to largely be in a holding pattern for partner testing as we wait for some of the imaging vendors to hash out re-orgs and get their respective Gateways reading for testing
- Hyland has committed Development resources towards the required Directory piece (their Gateway build is complete) and is slowly making progress there
- Nuance is getting really close to testing. We walked through the testing worksheet; endpoints, scenarios, test patients, etc during our last check-in
- We're hoping to see Hyland and Nuance kick-off partner testing in November



# 'On The Behalf Of' Queries Update

#### 'On The Behalf Of' Queries Update

- Background: Many Implementers wanted to add apps as CC's to initiate queries that don't necessarily have the ability to respond to queries. However, the clinical data can be retrieved from another entity in the Carequality ecosystem. A Tiger Team was formed in May to address this need
- The team completed its work and has identified the technical requirements needed for this new type of CC, which will be 'rolled in' to the new R4 Directory
  - o Add an "OTBO" value to the Initiator Only code set
  - o Add an "OTBO" FHIR Extension type Identifier
- The Policy requirements for this new functionality are being rolled in a future update to the <u>Carequality Framework Policies</u> document
- OTBO will be available (targeting Q1 2023) once the FHIR R4
   Directory is in Prod and the Framework Doc has been updated

#### Payment and Health Care Operations

- Proposed policy highlights:
  - Care Coordination Definition Care Coordination as defined in the Carequality context
    - References the established Health Care Operation definition
  - New Permitted Purpose The preferred way to convey to a query's purpose to a Responder is to label the query itself at the Permitted Purpose level.
  - Transaction Logs Defines data required to be conveyed by Initiators in order to facilitate transaction logs.
    - Requirements added apply to the Treatment, Health Care Operations, and Care Coordination purposes.

#### Patient Requests

- Proposed policy:
  - Responders MUST only match based on the approved set of demographics for Patient Request queries. Responders MAY use any of the items in the demographics superset list for matching, however, they MUST NOT require any individual item not included in the "Must" section of that list. Responders MAY use fewer than the full list of demographics, but they may not require additional demographic types to achieve an acceptable match (as defined as up to 100% match). If a Responder achieves an acceptable match on these demographics they must respond.
