

Update Process

- Last updated in 2019
- Minor updates—mostly clarification—needed for federal agency participation
- Steering Committee approval of Proposed Final Version, Thursday June 2nd
- o Implementer Objection Period closes July 2nd
- Effective Date August 1st

FHIR IG Workgroup Update

- The workgroup is wrapping up some final edits to create a new version (V2) of the FHIR IG
 - Removed all redundant policy language and now largely point to the overarching Carequality Framework Policies Element: <u>https://carequality.org/wp-</u> <u>content/uploads/2022/03/Carequality-Framework-Policies-</u> <u>v1.0-20220307-FINAL-1.pdf</u>
 - Updates to the security/authentication pieces as UDAP goes through the HL7 balloting process: <u>https://hl7.org/fhir/us/udap-security/2021Sep/</u>
 - More flexibility around certificates and allowances for Implementers to have more governance/control over this process
- We hope to wrap up the WG sometime in July then have V2 of the IG go through the Carequality update process in August

Image Exchange Update

- We are in a holding pattern for partner testing as we wait for some of the imaging vendors to hash out re-org and get their respective Gateways reading for testing.
- However... we're exploring the possibility of moving 1 Implementer (Hyland) to Production.
- This would essentially allow them to exchange images with other Hyland customers; a capability they currently do <u>not</u> have.
- To this end, Hyland has kicked off their initial work on the Directory to make this a reality.

FHIR R4 Directory Update

- We've given R4 Dev Directory access to a number of Implementors to test out the new Directory Implementation Guide and server
- As they navigate through this new environment, we await their feedback and will answer any questions they have
- We'll continue this process through June/July then review the data we've compiled
- We'll figure out next steps/timelines for migrating to R4 as we complete our review and react to any necessary changes

"On Behalf of" Queries Tiger Team

- This Tiger Team kicked off last month because many Implementers want to add Apps as CCs to initiate queries that don't necessarily have information that should be shared in response
- However, the patient's clinical data <u>can</u> be retrieved from another entity in the Carequality ecosystem
- The workgroup continues to explore the best way to make this happen, but we expect to add a couple of values to two separate Directory code sets
- We're also working on adding policy guidelines for whatever solution is deployed, but we're expecting that this functionality will be rolled out with the new Directory (see previous Directory update)

Patient Request Policy Diagram

Initiator (Patient) Via Carequality Implementer/CC (Consumer App) XCPD Contains ONLY verified demographics

<u>CSP</u>

-Verifies Patient to IAL2

-App responsible for patient identification service charges

Responder

(Ex. Provider Org)

-Conducts patient match utilizing any combination of an approved demographic set

-Response required for 100% unique match (based on their own definition) where applicable law allows
